Setup Requirements Visual Version 8.1.0.0

Each update of visual will extract the SQL_MagMedia folder that will tell visual to run the SQL functions from within visual. SQL functions are reflected as Quarterly Icon on the Payroll Menu. Users will need to close visual and perform the below steps to utilize the default visual functions. If the user is continuing with the SQL function they will need to refer to the SQL instructions for Quarterly reporting.

Renaming SQL folder to use Visual files

After each version perform the below to enable the visual function.

1. Navigate to the COATS12 folder, this can be done by right clicking your COATS visual icon and clicking open file location.
2. Locate the SQL_MagMedia folder
3. This can be removed by right clicking and delete
OR
This file can be renamed to a unique file name. Example is '_20200110_SQL_MagMedia' (without quotations). If entered file name already exists the user will need to either remove other file or choose a different file name.
4. Exit the folder.
5. Log back into Visual. User will see Quarterly and Yearly icons in the Payroll menu vs the MagMedia icon.

2022 Changes

- WA Quarterly Adjustment SOC has been added to the file. This pulls from the Employee Tax window. Users enter the highest SOC that applies for the employee.

- WV Quarterly Adjustment. SOC has been added to the file. This pulls from the Employee Tax window. Users enter the highest SOC that applies for the employee.

Quarterly

The quarterly processing of payroll information provides management with much needed and sometimes required reports pertaining to employee payroll and taxes. With COATS, Quarterly processing is simple and easily executed.

NOTE: Users should be aware because of the nature of the data being reported, both staff and temp payroll information will appear in the reports generated in this section. Users who should not be able to access staff records should not have access to Quarterly Section.


Federal Quarterly Report





FUTA By State Summary

Effective 2010 Credit Reductions were established for States that borrow funds from the federal government to pay unemployment claims. These states have a set period of time to repay this loan to the government. For states that have outstanding loans, they will receive a reduction in the FUTA credit. This information is reviewed by the US Department of Labor (DOL) to determine which states have repaid their loans and which states are outstanding on their repayment. The DOL publishes this information in November that will retroactively apply for the current year.

The FUTA By State Summary Report is a list of each state in which the agency pays unemployment tax and corresponding rate, as listed in the Federal Tax

Table, during the selected date range. This report is not based on view and will pull all payroll information.

The report prints State Initials, Eligible FUTA Wages, Tax Rate, and Quarterly Unemployment Tax.

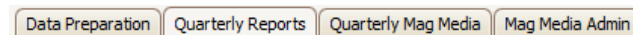

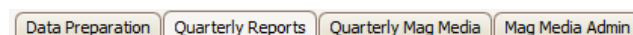

Known Quarterly errors

- **Unable to select a state** – Indicates data not generated from the Data Preparation tab.
- **All States Listing on the Right Grid multiple times after data generated** – Indicates No data gathered for selected time frame
- **`Error in Mag_States Table - State Initials State Information Not Found!`** - Indicates State Address details were not addressed in the Data Preparation Tab. The user must select the state from the list on the right grid in this tab and update the state details in the lower box on the left.

Mag Media / State Quarterly Report(s)

The Mag Media option allows the user to generate magnetic media to be submitted to the state for state unemployment purposes. The user will be prompted to indicate for which state they want to create this data. If the user operates in multiple states, it will be necessary to run the procedure multiple times, once for each state, as each state has its own magnetic media requirements.

Magnetic media is a term that means to file the tax data electronically, by floppy or uploading on the internet. Each state has a specific format and list of data they need included in the file that is sent. COATS has created a unique program and screen for each state to accommodate these needs. For questions regarding where to send the magnetic media or how to label it, please contact the agency's state.

VT – Vermont – Visual has CSV format

WV – West Virginia – File Name should read qtrwages.es, Add leading zeros to the 6 digit UID and do not include dashes

WY – Wyoming – Not required to electronically file,.
